Fifth paragraph, third sentence:

Old: ... (single effects of farm type: $\chi^2_1 = 164.96$, $p < 0.001$; $\chi^2_1 = 3.98$, $p = 0.046$, ...). ... ($\chi^2_1 = 1.31$, $p = 0.252$)

New: ... (single effects of farm type: $\chi^2_1 = 165.29$, $p < 0.001$; $\chi^2_1 = 4.20$, $p = 0.040$, ...). ... ($\chi^2_1 = 1.27$, $p = 0.260$)

Fifth paragraph, fourth sentence:

Fifth paragraph, last sentence:

Old: ... (single effects of percentage of land with agri-environment scheme: $\chi^2_1 = 51.97$, $p < 0.001$; $\chi^2_1 = 6.91$, $p = 0.009$; $\chi^2_1 = 13.24$, $p < 0.001$, respectively; Appendix A, Table 2), but not on bird species diversity ($\chi^2_1 = 1.56$, $p = 0.211$)

New: ... (single effects of percentage of land with agri-environment scheme: $\chi^2_1 = 52.15$, $p < 0.001$; $\chi^2_1 = 7.24$, $p = 0.007$; $\chi^2_1 = 13.13$, $p < 0.001$, respectively; Appendix A, Table 2), but not on bird species diversity ($\chi^2_1 = 1.45$, $p = 0.228$)
